5.1 Mission	The evaluation of knowledge and competencies required for the scientific and methodologic fundament of the theme chosen for the elaboration of the dissertation project, as well as for the formulation of an applied response regarding the theoretical problematization, materialized through a project or an applied case study.
5.2 Conditions required to carry out the dissertation paper writing	 The activity for this class consists of the elaboration of a dissertation thesis in order to graduate the master program, on a theme chosen according to the indications specified at chapter 8.1, going through the following stages: Stage I (theoretical) – Research paper: consists of the elaboration of a research paper, which represents the theoretical and methodological fundament of the theme chosen to be detailed in stage II; Stage II (practical) – Dissertation project / Applied case study: consists of the elaboration of a project or of an applied case study, based on the thematic and principles established in stage I; The students are obliged to establish and participate in at least 3 discussion sessions with the coordinator; for each session of discussion, students will prepare
